The BSB50215 Diploma of Business is an Australian accredited qualification that provides the participant with necessary knowledge and skills to effectively function within the corporate environment.



## BSB50215 Diploma of Business Requirements:

- Completion of Year 12
- Achieved Academic IELTS of 5.5, or TOEFL IBT 52, or equivalent

#### **RMIT English Requirements:**

Please note that all international students must meet the English language entry requirements set by RMIT in order to enrol in an undergraduate degree. The English requirement for RMIT undergraduate business degrees are as follows:

- IELTS (Academic): minimum overall band of 6.5 (with no individual band below 6.0)
- TOEFL (Paper Based Test): minimum score of 580 (TWE 4.5)
- TOEFL (Internet Based Test IBT): minimum overall score of 92 (with minimum of 20 in all sections)
- Pearson Test of English (Academic) (PTE (A)): minimum score of 58 (with no communication band less than 50)
- Cambridge English: Advanced (CAE): minimum of 176 with no less than 169 in any component.
